

KNOWLEDGE PLATFORM – TERMS OF USE LICENCE AGREEMENT

This Terms of Use Licence Agreement (“Terms of Use Agreement”) sets out the rights and obligations between you (“You”) and the Wildfire Resilience Consortium of Canada (“WRCC”) regarding Your access to and use of the WRCC Knowledge Platform (“Knowledge Platform”) and Your access to, viewing, downloading, reproduction and distribution of the articles, papers, reports, documents, presentations, videos, research, data or other content (“Materials”) available through the Knowledge Platform.

IMPORTANT

This Terms of Use Agreement is a binding legal agreement between You and WRCC. Please read the terms and conditions set out herein carefully. Clicking “I agree” when registering with the Knowledge Platform and creating a user account indicates Your acceptance of these terms and conditions. If you do not agree to the terms or conditions (or any of them), you are not permitted to access the Knowledge Platform or the Materials contained on the Knowledge Platform. If you have questions regarding the Terms of Use Agreement, the terms or conditions thereof, please contact [contact name/email].

The rights and licenses granted to You herein to access and use the Knowledge Platform and to access, view, download, reproduce, use and distribute Materials available through the Knowledge Platform are for Your personal, non-commercial use only and for the purpose of research, private study and education (the “Purposes”).

- f. Certain Materials on the Knowledge Platform are subject to specific restrictions regarding access, viewing, use, reproduction and distribution (“Materials-Specific Restrictions”). Materials-Specific Restrictions that apply to any Materials form are [clearly indicated in relation to such Materials]. The general rights and licenses granted to You herein regarding access to, viewing, downloading, reproduction, use and distribution of Materials available through the Knowledge Platform are limited by the Materials-Specific Restrictions (if any) that apply in respect of any Materials to which such restrictions apply. You are responsible for reviewing and complying with any Materials-Specific Restrictions applicable to specific Materials before downloading, reproducing, or distributing such Materials.**
1. User Account. You require a user account (“Account”) to access and use the Knowledge Platform and to access, view, download and reproduce any Materials. You are responsible for all access to the Knowledge Platform and Materials using Your Account and for all activity conducted using Your Account. You must not allow any other person to access the Knowledge Platform or to access or download any Materials using Your Account.
2. Licence Grant. Subject to the terms and conditions of this Terms of Use Agreement and any restrictions Materials-Specific Restrictions, WRCC grants You the following limited, non-exclusive, non-transferable, non-sublicensable, royalty-free, revocable rights and licenses:

 - a. a right and license to access the Knowledge Platform;
 - b. a right and license to access, view and use Materials on the Knowledge Platform;
 - c. a right and license to download Materials (where such functionality is made available);

- d. a right and license to reproduce and distribute copies of Materials downloaded from the Knowledge Platform (where such functionality is made available).

For clarity:

- e. The rights and licenses granted herein are for the Purpose only and for no other purposes;
- f. Unless otherwise agreed in writing between You and WRCC, the right to reproduce and distribute copies of Materials made available through the Knowledge Platform is limited to the right to distribute copies of such Materials internally within your organization;
- g. where any Materials-Specific Restrictions apply to specific Materials, such restrictions shall be deemed to prevail over the general rights and licenses granted herein in respect of Materials to the extent of any inconsistency; and
- h. Except for the specific rights and licenses granted herein, no other right or license in or to any Materials available through the Knowledge Portal is granted to You (including without limitation any right to modify, amend, translate, or create derivative works of any Materials (in whole or in part), to repost or distribute any Materials (in whole or in part) or to use or otherwise exploit any such Materials for any purpose other than the Purposes).

3. Restrictions on Access to and Use of the Knowledge Platform. You shall not:

- a. use any automated means, including scraping, data mining, or crawling, to access, download, or index the Materials on the Knowledge Platform;
- b. access or use the Knowledge Platform in any manner which may compromise or interfere with the security, integrity, or operation of the Knowledge Platform or which may interfere with the use, performance, or enjoyment of the Knowledge Platform by any other user;
- c. attempt to gain unauthorized access to any portion, feature, or content of the Knowledge Platform to which You has not been provided access, or attempt to defeat or circumvent any security feature, registration requirement, or other restriction mechanism of the Knowledge Platform; or
- d. attempt to gain access to the account of any other user of the Knowledge Platform.

4. Intellectual Property.

- a. All right, title, and interest in and to the Materials (including all intellectual property rights therein), are, and shall remain at all times, the property of the owners of such Materials and the rights therein. Nothing in this Terms of Use Agreement shall be construed as transferring any ownership rights in or to any Materials to You.
- b. You shall not remove, obscure, or alter any copyright notice, attribution, or proprietary legend in or on any Materials (including the WRCC name, logo and related trademarks) including in any copies of any Materials downloaded from the Knowledge Platform; and
- c. The WRCC name, logo, and all related trademarks are the property of WRCC and may not be used by You without the prior written consent of WRCC.

5. **Disclaimer.** The Knowledge Platform and the Materials available through the Knowledge Platform are provided on an “as is” and “as available” basis. WRCC does not endorse, approve, or certify any Materials and disclaims all liability in connection therewith.

To the fullest extent permitted by applicable law, WRCC, on behalf of itself and its consortium members, affiliates, officers, directors, employees, agents, contributors, and licensors, specifically disclaims all representations and warranties of any kind, express, implied, or statutory, with respect to the Knowledge Platform and the Materials available through the Knowledge Platform, including any and all representations and warranties regarding merchantability, fitness for purpose, and non-infringement and any representation or warranty regarding:

- a. the accuracy, completeness, currency, correctness or reliability of any Materials (in whole or in part);
- b. non-infringement, violation or misappropriation of any third-party rights (including any intellectual property rights) that may arise as a result of Your use or other exploitation of any Materials;
- c. the fitness of any Materials for any purpose, Your reliance upon such Materials or the results You may obtain from the use or other exploitation of such Materials; or
- d. the uninterrupted, proper, or error-free availability of the Knowledge Platform or any Materials (including any representation or warranty that the Knowledge Platform or any Materials do not contain any virus, other contaminants or malignant code).

You specifically acknowledge and agree that:

- e. You are solely responsible for Your selection of and use of the Materials and for any results (or lack thereof) You may achieve through use of or reliance upon the Materials and
- f. You assume all risk arising from, out of or in connection with Your access to and use of the Knowledge Platform and the Materials.

6. **Takedown and Removal of Materials.** WRCC reserves the right to remove or disable access to any Materials on the Knowledge Platform (in whole or in part) at any time and for any reason (including in response to a complaint or notice of alleged copyright infringement), without prior notice to You. You acknowledge and agree that WRCC has no obligation to continue to make any specific Materials available nor any liability to You for the removal of any Materials from the Knowledge Platform. You acknowledge and agree further that You shall comply with any instructions from WRCC regarding further or continued use or other exploitation of any Materials subject of any take down or removal from the Knowledge Platform.

7. **Limitation of Liability.** You acknowledge and agree that, to the fullest extent permitted by applicable law, in no event shall WRCC be liable to You or any other person or entity for any of the following arising from, out of, or in connection with this Terms of Use Agreement, the subject matter hereof, or the access to, use of, or reliance upon any Materials by You, whether or not foreseeable and regardless of the cause of action or the theory of liability: (a) direct damages in any amount; or (b) indirect, incidental, consequential, special, exemplary, or punitive damages, including damages in the nature of loss of profits, revenue, or data.

8. Indemnification. You shall indemnify, defend, and hold WRCC and its affiliates, consortium members, officers, directors, employees, agents, successors, and assigns (each, a "WRCC Indemnified Party") harmless from and against all damages, losses, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, fees, costs, or expenses of whatever kind, including reasonable legal fees (collectively, "Losses"), arising from, out of, or in connection with any claim, suit, action, or proceeding by any person or entity: (a) alleging a material breach by You of any term or condition of this Terms of Use Agreement; (b) alleging that Your access to and use of the Knowledge Platform or access to, use, viewing, downloading, reproduction or distribution of any Materials is not in accordance with the terms and conditions of this Terms of Use Agreement; or (c) alleging that any use or other exploitation by You of any Materials which is not in strict accordance with the terms and conditions of this Terms of Use Agreement constitutes an infringement, violation, or misappropriation of the intellectual property rights of any person or entity.

9. Termination

- a. WRCC may terminate or suspend Your access to the Knowledge Platform and the rights and licence granted herein at any time, with or without cause, and without prior notice.
- b. You may terminate this Agreement at any time by closing Your Knowledge Platform account; and
- c. Upon termination of this Agreement for any reason: (a) all rights and licences granted to You under this Terms of Use Agreement shall immediately cease; and (b) You shall immediately cease all access to, and use of the Knowledge Platform and all Materials downloaded from the Knowledge Platform.

10. General Provisions

- a. Governing Law. This Terms of Use Agreement is governed by, and shall be construed in accordance with, the laws of the Province of Ontario and the federal laws of Canada applicable therein, without regard to conflict of laws principles. You irrevocably submit to the exclusive jurisdiction of the courts of the Province of Ontario in respect of any dispute arising out of or in connection with this Terms of Use Agreement.
- b. Entire Agreement. This Terms of Use Agreement constitutes the entire agreement between You and WRCC with respect to Your access to and use of the Knowledge Platform and the Materials and supersedes all prior or contemporaneous understandings, agreements, representations, and warranties, whether written or oral, with respect to such subject matter.
- c. Amendments. WRCC may amend this Terms of Use Agreement at any time by posting revised terms on the Knowledge Platform and providing notice to You by email or through Your Knowledge Platform account. If You do not agree to the terms of any such amendment, You may terminate Your account and this Terms of Use Agreement in accordance with the termination provisions herein. Your continued access to and use of the Knowledge Platform following the posting of any amended Terms of Use shall constitute the Your acceptance of such revised terms.
- d. Severability. If any term or provision of this Terms of Use Agreement is held to be invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability will not affect the enforceability of any other term or provision of this Terms of Use Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

- e. Electronic Acceptance. By accessing or using the Knowledge Platform, You acknowledge and agree that such use constitutes acceptance of this Terms of Use Agreement with the same legal force and effect as a manual signature. No physical or electronic signature, wet ink execution, or counterpart exchange is required to make this Terms of Use Agreement binding and enforceable.
- f. Interpretation. In this Terms of Use Agreement, unless the context otherwise requires, the word “including” (and its grammatical variations) means “including, without limitation”.
- g. Survival. The following sections shall survive the termination of this Terms of Use Agreement: 3, 4, 5, 7, 8 and 10 together with any other provision of this Agreement that by its nature or context is intended to survive termination.
- h. Assignment. This Terms of Use Agreement is personal to You. Neither this Terms of Use Agreement, nor the rights or obligations hereunder, may be assigned or transferred by You (in whole or in part) without the prior written consent of WRCC. WRCC may assign or otherwise transfer all or any of its rights and obligations under this Terms of Use Agreement without Your consent.
- i. Compliance with Applicable Law. You shall comply with all applicable laws while exercising Your rights and performing Your obligations under this Terms of Use Agreement and shall not knowingly do anything which is harmful or detrimental to WRCC in any way or which may expose WRCC to liability of any kind.
- j. Relationship of the Parties. Nothing in this Terms of Use Agreement shall be deemed or construed as creating any agency, partnership, employment, or joint venture relationship between You and WRCC.
- k. Notices. All notices under this Agreement shall be in writing and sent by email. Notices to You shall be sent to the email address associated with Your account. Notices to WRCC shall be sent to [contact email]. Notices shall be presumed received on the business day following the day the email is sent, provided the sender receives no error in delivery message within twenty-four (24) hours of attempted delivery.
- l. Privacy. WRCC collects, uses, stores, and discloses personal information in accordance with its Privacy Policy located at [URL]. The User shall comply with all applicable privacy legislation regarding the disclosure and provision of any personal information through the Knowledge Platform.
